1. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

To consider and if thought fit, to pass, with or without amendment, the following resolution as a **non-binding** resolution:

"That for the purposes of section 250R(2) of the Corporations Act, and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company's annual financial report for the financial year ended 30 June 2021."

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared for the information of the Shareholders of the Company in connection with the business to be conducted at the Annual General Meeting to be held at Country Women's Association of WA, Level 2, 1176 Hay Street, West Perth, Western Australia on Tuesday 30 November 2021 commencing at 11.00am (WST).

The purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting. It should be read in conjunction with the Notice of Meeting.

For those Shareholders who have not elected to receive a hard copy of the Annual Report, it can be accessed on the Company's website at **www.redhilliron.com.au**.

FINANCIAL STATEMENTS AND REPORTS

The annual financial report of the Company for the financial year ended 30 June 2021 together with the declaration of the Directors, the Directors' report, the remuneration report and the auditor's report are presented for consideration at the Meeting.

The Chairman will allow a reasonable time for shareholders to ask questions about or make comments on the management of the Company. Shareholders will also be given a reasonable opportunity to ask the auditor questions about the conduct of the audit, and the preparation and content of the auditor's report, the accounting policies adopted by the Company and the independence of the auditor in relation to the conduct of the audit. There is no requirement for shareholders to approve these reports.

1.0 RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

1.1 General

The remuneration report sets out the Company's remuneration arrangements for the Directors and senior management of the Company. The remuneration report is part of the Directors' report contained in the annual financial report of the Company for the financial year ended 30 June 2021. A reasonable opportunity will be provided for discussion of the remuneration report at the Annual General Meeting.

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the remuneration report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the Directors or the Company.

1.2 Voting consequences

Under the Corporations Act if, at two consecutive annual general meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report, then a further resolution (**Spill Resolution**) may be required to be considered at the second annual general meeting as to whether a further meeting be convened to put certain Directors to re-election. The Directors to be put to re-election are those Directors, other than the Managing Director, who were Directors when the resolution to make the directors report was passed.

1.3 Previous voting results

At the Company's previous annual general meeting the votes cast against the remuneration report considered at that annual general meeting were less than 25%. Accordingly, a Spill Resolution will not be relevant for this Annual General Meeting.

2.0 RESOLUTION 2 - RE-ELECTION OF A DIRECTOR - GARRY STRONG

2.1 General

Clause 14.2 of the Constitution requires that, at the Company's annual general meeting in every year, one-third of the Directors for the time being shall retire from office, provided always that no Director except the Managing Director shall hold office for a period in excess of 3 years, or until the third annual general meeting following his appointment, whichever is the longer, without submitting for re-election.

A Director who retires by rotation under clause 14.2 of the Constitution is eligible for re-election. Accordingly, Mr Garry Strong, who was last re-appointed by Shareholders at the 2019 Annual General Meeting on 29 November 2019, retires in accordance with the Constitution and, being eligible for re-election, offers himself for re-election at the Annual General Meeting.

2.2 Qualifications and other material directorships

Mr Strong has been a Director of the Company since 1 June 2005.

Mr Strong is a prospector with a lifetime of experience in mineral exploration in Australia and is a founding director of Red Hill Iron. Mr Strong has held no other directorships in ASX listed companies during the last three financial years.

2.3 Independence

Mr Strong is considered an independent Director of the Company.

2.4 Board recommendation

The Board supports the election of Mr Strong and recommends that Shareholders vote in favour of Resolution 2.

3.0 RESOLUTION 3 – ELECTION OF A DIRECTOR – NANETTE ALLEN

3.1 General

Clause 14.4 of the Constitution requires that a person appointed by the Directors as a Director holds office only until the Company's next following Annual General Meeting and is then eligible for re-election.

Accordingly, Ms Nanette Allen, who was appointed a Director on 1 February 2021 ceases to hold office at the conclusion of this Annual General Meeting and, being eligible for re-election, offers herself for election.

3.2 Qualifications and other material directorships

Ms Allen, BSc (Hons), MAICD, MAusIMM, has been a Director of the Company since 1 February 2021.

Ms Allen has worked in the resource sector as a mining executive and geologist and has a wealth of technical and corporate experience. Her career has focussed on strategy implementation, mine development, joint venture management, capital raisings and asset divestments. Ms Allen has held no other directorships of ASX listed companies during the last three financial years.

3.3 Independence

Ms Allen is considered to be an independent Director of the Company.

3.4 Board recommendation

The Board supports the election of Ms Allen and recommends that Shareholders vote in favour of Resolution 3.
